PRIVACY POLICY

Protecting your information is our top priority. This privacy policy governs data collection and usage. COLLECTION OFY OUR PERSONAL INFORMATION

We do not collect any personal information from you unless you voluntarily provide it to us. However, you may be required to provide certain personal information when you elect to use certain products or services. All such third parties are prohibited from using your personal information except to provide these services to us, and they are required to maintain the confidentiality of your information.

We may disclose your personal information, without notice, if required to do so by law, or in the good faith belief that such action is necessary to (a) conform to the edicts of law or to comply

with legal process served upon us, (b) protect and defend our rights and property, and/or (c) act under exigent circumstances to protect the personal safety of our users or the public.

OPT-OUT OF DISCLOSURE OF PERSONAL INFORMATION TO THIRD PARTIES

Complete the transaction for which your personal information was collected, fulfill the
terms of a written warranty or product recall conducted in accordance with federal law,
provide a good or service requested by you, or reasonably anticipated within the context of

our ongoing business relationship with you, or otherwise perform a contract between you and us;

- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity, or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the rights of others to exercise their right to free speech, or exercise another right provided by law;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adhere to all applicable ethics and privacy laws, when our deletion of information is likely to render impossible or serious impair the achievement of such research, provided we have obtained your personal consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

CHILDREN UNDER THIRTEEN

Giarratana, LLC does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must get permission from a parent or guardian to use our products and services.
